Summary of the meeting discussions

1. Conference objectives and target audiences

Key Objective(s):

SAMS Conference, May 2018:

A first MacroFuels conference with a 'policy and licensing for large-scale seaweed farming' focus would be most interesting and would allow for well targeted sessions with a defined target audience.

Reasons:

- MacroFuels needs to initiate dialogues and knowledge exchange on requirements for licenses for largescale seaweed farms to secure upscaling of seaweed cultivation in European sites
- This is in line with our exploitation and communication strategy and to secure maximum support and public/political endorsement for large-scale seaweed cultivation and farming and complements activities initiated by partners SAMS (e.g. contribution to Scottish Seaweed Cultivation Guide) and dialogues initiated by MacroFuels with Dutch policy makers and pilot initiatives on integrated wind parks/seaweed cultivation (see press release at https://www.zuid-holland.nl/@19030/zeewierteelt/).
- Policies in Scotland are yet limited to small and medium-scale seaweed cultivation, and input is needed for developing policies for upscaling. MacroFuels can provide knowledge and visions for large-scale seaweed farming at pre-legislation level.
- Possibly competing interest and resulting conflicts with other marine business sectors (e.g. fisheries, other aquaculture, transport, offshore wind parks etc.), but also environmental protection and conservation (keyword: marine mammals) could be mitigated via early dialogues and integrated approaches.
- Public support (e.g. local residents) is needed, so policy makers have the public mandate to endorse largescale seaweed farming

Suggested key motto of the MacroFuels conference at SAMS: "What is needed to make large-scale seaweed farming licensable?"
